Introduction

The following pages list data for all known family members as of November 28, 2024.

Each immediate family is presented in their own section that contains a graphical family tree as well as a description with information about each referenced person and their children. The child section provides information about the children of the preceding couple. When a child has offspring of their own this is presented in a separate family section for that child. In this case a '+' is used to denote that an individual will appear later in the book as a parent with his/her own children and there is a link to the appropriate family reference number. For children with partners but no offspring the partner data is given with the reference family. Roman numerals, followed by a period, are used to indicate the birth order.

In the chapter titled "Family of the Starting Person" the ancestors of John Kelly and Julia Kennedy are presented in a kind of enhanced Pedigree Chart which displays the graphic representation of their direct-line ancestors and the children of the couple. This chapter contains information about the couple whose offspring are listed in the later chapters.


The chapter titled "Families of his Descendants" provides details (as known as of the publication date) for the offspring of John Kelly and Julia Kennedy. There is a chapter for each generation. Relatives are listed in the order of the nearness of their relationship.

Sources for the information provided are given in the footnotes.

This document reports the details of 146 individuals, of whom 78 are male and 68 are female. Of the 31 individuals with recorded birth and death dates, the average lifespan was 67.7 years. Of these, 18 males averaged 64.6 years, and 13 females averaged 72 years. The longest living male was James Joseph Hyde Jr. (1933–2021), who died aged 88. The longest living female was Marion Frances Munday (1932–2018), who died aged 85.




Figure 4: 1911 Irish census of John Kelly and family





Figure 6: Draft card





Figure 8: Draft card






Figure 10: 1930 census of James Hyde




Figure 14: Gravestone






Figure 18: Draft card





Figure 21: Draft card





Figure 27: Obituary




Figure 34: Capt David Bergeron on left of Sheriff Eisenstadt




Figure 36: 140 - Obituary




Figure 38: 143 - Obituary




Figure 41: Bob Kelly yachting





Figure 53: 1940 census of Joseph and family








Figure 54: Christine and Alex, Falmouth, 2004






