IMPORTANT INFORMATION ABOUT THIS FAMILY HISTORY

This family history is not complete or correct.

It can't be—time blurs the details, secrets remain hidden, investigations hit dead ends, babies are born, and people die, marry, and divorce with unpredictable frequency. It also takes time for family members to confirm or correct its contents.

Consequently, at best, this is a work-in-process...like the family itself.

WHO'S INCLUDED AND WHO'S NOT?

For the oldest ancestor, the person at the start of the bloodline, and his descendants...

This family history INCLUDES all the known:

- Children, both male and female, including those who are:
 - Illegitimate
 - Legally adopted
 - Step (added to the family through marriage)
 - Taken in (unofficially added to the family)
- Brothers and sisters
- Legal spouses and other partners including those who are a:
 - Common law wife or life partner
 - Biological parent of a child who is not a biological child of the descendant
- Parents of a spouse or partner

This family history EXCLUDES all the known:

- Children of a descendant's brother or sister
- Brothers and sisters or a descendant's spouse or partner
- Grandparents of the descendant's spouse or partner

Note that these genealogical rules do not trace the line by the *family name*, nor do they favor *biological children*, nor do they make any distinction between *male and female descendants*.

HOW IS THIS FAMILY HISTORY ORGANIZED?

...By the nuclear families—the descendant, his spouse, and his children—where each nuclear-family section contains:

- A family tree showing the descendant's family, his parents, and his spouse's parents
- Key facts about the members of the nuclear family (marriage date, birth dates, etc.)
- Photos and historical documents that apply to the nuclear family as a whole (to avoid duplication)

At the end of the document, there's:

• A *bibliography* that lists research sources

- A *name index* that lists all the names found in the family history
- A *place index*, and lists all the places found in the family history
- a traditional family tree (a descendant chart) that show everyone in the family

WHAT CONVENTIONS ARE USED?

Most of the kinds of relationships in this history—parents, grandparents, great grandparents, brothers, sisters, aunts, uncles—are well known; however, there are some that are not:

• Greats

Rather than repeat the word "great" for each generation, they are numbered. For example, a great grandfather is the first great grandfather, a great grandfather is the second great grandfather, and so on. This applies to great aunts and uncles as well.

• Cousins -

First cousins have the same grandparents; second cousins have the same great grandparents; third cousins have the same great great grandparents, and so on.

• Removed

The parents of first cousins are first-cousins-once-removed, that is, one generation removed; the grandparents of a first cousin are the first-cousins-twice-removed, that is, two generation's removed, and so on.

• In-Laws

The term in-law identifies a legal rather than a biological relationship, such as a motherin-law or a brother-in-law. We often drop this when referring to an aunt, uncle, or cousin, or replace it with the words "by marriage" such as in "my cousin by marriage."

This history assigns a unique number to the oldest ancestor and his descendants. It appears in the family tree, various lists, and the text.

Descendants appear in birth order-oldest first.

The family history uses three kinds of images—profiles, pictures, and documents. Profiles are thumbnails faces, pictures are important images, documents are key records. All three are linked to an individual, but picture and documents are only shown once at the end of each family section to avoid duplication.

The abbreviations [fnu] and [lnu] stand for "first name unknown" and "last name unknown."

I try to use the "best" pictures I have for descendants. By "best," I mean the one that shows what the person looked like for most of his or her life. However, when all I have is a "kid picture" or an "old person picture," that's what I use.

HOW CAN I SEE THE FAMILY HISTORY ONLINE?

...Through *ancestry.com* under the family name. I keep the family tree database on my computer and sync its public data with *ancestry.com*, I never sync or share the private date in the database—

current addresses, medical histories, birth certificates, divorce information, etc.

HOW CAN I ADD, CHANGE, OR REMOVE DATA?

...Send me an email or a letter. I will either make the change myself or add you an editor on *ancestry.com*. Ancestry.com will automatically sync your changes to the database on my computer.

If you want to maintain the family tree or a branch of the tree yourself, send me an email or a letter and I will send you the appropriate computer file.

STATISTICS REGARDING THE FAMILY HISTORY OF Luigi CALDARELLA and Carmella LIVACCARI

This document reports the details of 47 individuals, of whom 22 are male and 25 are female. Of the 10 individuals with recorded birth and death dates, the average lifespan was 74.1 years. Of these, 4 males averaged 76.1 years, and 6 females averaged 72.8 years. The longest living male was Louis CALDARELLA (1918–2012), who died aged 94. The longest living female was Giuseppina BARBERA (1897–1988), who died aged 90.

Godrano Sicily




Our ancestors are from the small municipality of Godrano, which is on a mountainside about 2,400 feet above sea-level near the city of Palermo in Sicily.

The history of Godrano is the history of Sicily. From 1194 until 1860, Norman, German, French, and Spanish conquerors ruled, with brief periods when Sicilians ruled themselves. In 1860, Giuseppe Garibaldi seized Palermo and made the city and eventually all of Sicily part of the United Kingdom of Italy. In 1943, the Allies bombed Palermo and quickly seized control of Italy from the Mussolini government then, just as quickly, returned control back to the Italians.

Palermo is the island's capital and it's chief port. It's here that most of Sicily's foreign trade occurs and where most tourism starts. Citrus fruits, cereals, fresh fish, and chemicals are the island's principal exports. Ship repair and the manufacture of chemicals, glass, cement, machinery, and processed foods are important industries.



2. FELICE CALDARELLA was born on Sunday, March 19, 1882, in Godrano, Sicilia. He was the son of Luigi Caldarella (1) and Carmella Livaccari. He was also known as Philip, Phillip and Felix.

In 1902, Felice lived in Manhattan (178 Avenue A). He arrived at New York City on May 18, 1902.

Felice Caldarella

Felice died in Manhattan on May 14, 1951, at the age of 69. The cause of death was a heart attack.

Felice married **GIUSEPPINA BARBERA** after December 8, 1910 in Manhattan. They had five children.

Giuseppina was born in Italy on Sunday, August 15, 1897. She was also known as **Josephine and Josephina**.

Giuseppina arrived at Manhattan after December 12, 1910. Manifest list origin as Godrano, Sicily. Martried aboard the ship, the S.S. Duca Degli Abruzzi. She reached 90 years of age and died in Rego Park on April 15, 1988.




Figure 4: 1920 census with Felice and family




Figure 5: Josephine marriage photo

3. LOUIS CALDARELLA was born on Sunday, July 7, 1918, in Manhattan. He was the son of Felice Caldarella (2) and Giuseppina Barbera. He was also known as **Lou** and **Louie**.

In 1940, Louis lived in Manhattan (Marital Status: Single; Relation to Head: Son).



He served in the military between 1942 and 1945 in Europe. Louis landed in France on D-Day as a Sherman tank commander and later served as an artilleryman. He was awarded the bronze star. In 2000, Louis lived in Red Hook, New York. In 2006, Louis lived in Pine Plains.

Louis died in Pine Plains on December 1, 2012, at the age of 94.

Louis married EMMA DIFEBO on Thursday, October 10, 1963. Emma was born in Pennsylvania in 1923.




Figure 10: Picture 046









Figure 12: Lou circa 2010

4. VINCENT CALDARELLA was born on Wednesday, April 7, 1920, in Manhattan. He was the son of Felice Caldarella (2) and Giuseppina Barbera. He was also known as **Jim** and **Jimmy**.

Vincent attended Cooper Union in Manhattan for three years until he was drafted.



Vincent Caldarella

In 1940, Vincent lived in Manhattan (Age: 20; Marital Status: Single; Relation to Head of House: Son). Vincent served in the military between February 3, 1942 and 1945 in Europe. He landed in Normandy on D-day+1 as a medic. In 1945, he was awarded the bronze star.

He worked as an insurance underwriter in Boston between 1946 and 1974. In 1955, Vincent lived in Lexington, Massachusetts.

He died in Lexington on February 17, 1974, at the age of 53. The cause of death was a heart attack.

At the age of 26, Vincent married **SANDRA DISILVA** on Sunday, November 10, 1946, in Boston when she was 23 years old. They had three sons.

Sandra was born in Somerville, Massachusetts, on Friday, August 10, 1923. She was also known as **Alexandrina**, **Alessandra** and **Sandy**.



Sandra DiSilva

Sandra reached 82 years of age and died in Lexington on November 17, 2005. The cause of her death was colon cancer, emphysema, and heart disease.


Figure 23: Tom, Joanne, Sandra, and Vincent DiSilva


Figure 30: Yvonne operating Citibank's first computer terminal to transfer money, 1968




Figure 34: Matt




Figure 38: Michael, Christina, Morgan, and Mitchel 2006




Figure 40: Bob in Army


Figure 42: Jane and Jack




Figure 46: Karen's wedding







Figure 51: Nick and Karen


Figure 53: Jack


Figure 59: Caroline


Figure 61: Millie, Josie, Dora...1946
